There is a recent spike in COVID-19 prevalence above 1% in La Plata County. Using models and our current risk tolerance of less than 1% chance of infection occurring, a 2-hr stay in Sanctuary is coming close to this risk tolerance. Congregants are probably safe using N95 masks; wearing surgical masks, they are probably safe for 90 minutes. Cloth masks are not safe. Song leaders are wearing singing masks.
